The Following terms and conditions.

**TERMS AND CONDITION**

1. This school shall follow course of study as per syllabus prescribed by the affiliated board .
2. The school shall charge fees and funds as declared to the appropriate authority at the time of application of recognition and display the same on the notice board of school and shall not increase the fees during the any academic session. In case of change in the fees structure the school shall inform to the appt. authority in the month of January for the next academic year and will also printed receipt of fees/to the student.
3. Sallry shall be paid as per declaration of the time of seeking recognition.
4. No completion fees and other admission without charges shall be charged from the Children/ parents.
5. School shall be open or admission without any discrimination based on religion, caste, race, and place of birth or any other whimsical.
6. Managing committee shall not allow to run two schools affiliated by the different board /council in the same premises.
7. Managing committee shall not close down the schools or an existing class during the academic session without the prior approval of the appropriate authority.
8. The school be open for inspection for the inspection office authorized by the Director/Appropriate authority.
9. Recognition shall be reviewed after every 10 years.
10. No Financial assistance shall be granted by the department to the school.
11. School premises assistance shall not be used for commercial purpose and anti national activities .
12. Approval of managing committee shall be obtained from the appropriate authority in case of any change in the committee.
13. The managing committee shall follow the instructions issued by the Govt./Director from time to time and supply the information to the Govt./Deptt from time to time.
14. In addition to above the managing committee shall avoid by the provisions of Haryana School Education rule 2003 and amendments if any thereafter the managing committee shall be liable or disciplinary action in case of violation of any rules.
15. School will provide a ramp with in six Month.
16. Managing committee will provide the trained staff according to Haryana Govt. Rules
17. School will Provide Fire extinguishers in school with in a month.
18. School will provide Stair riling and roof parapet is also provided for Safety of children with in 10 days and informed in this office .
